I Ann Randall of Veny Sutton in the County of Wilts Widow do revoke all former Wills by Me at any time heretofore made and Declare my Last Will and Testament to be as follows first I give my Granddaughter Elizabeth Mead my Piece of Gold that I wear about my Neck I give to my Grandson William Randall my Great Chest I give to my Granddaughter Mary Randall my Chest of Drawers All the rest of my Household Goods I give to my Son John Randall I give to my Daughter Edith the Wife of William Long and to my Granddaughter Mary Randall between them all my Wearing Apparel both Linnen and Woollen I give to my Granddaughter Elizabeth Mead ffive Pounds I give to my Granddaughter Edith Long ffive Pounds and to Each of my Son John's Children ffive Pounds I give a Gold Ring to each of my Granddaughters Edith Long Elizabeth Mead Ann and Mary Randall I give to the Wife of my Son Richard a Gold Ring I give to Stephen Crowch of Tytherington in the said County of Wilts Esq and John Bennett of Warminster in the said County Gent Ninety Pounds to be by them paid to my said Daughter the Wife of William Long in such manner as my said Daughter shall Direct and Appoint notwithstanding her Coverture and the said Ninety Pounds to be placed out at Interest by the Approbation of the said Edith my Daughter and the Interest to be paid to her alone and her receipt alone shall be a sufficient Discharge notwithstanding her Coverture and in Default of any Direction or Appointment of my said Daughter Edith touching the payment of the said Ninety Pounds by the said Stephen Crowch and John Bennett The to be paid to the Executors or Administrators of the said Edith my Daughter I give to Each of my Granddaughters Mary Randall Ann Randall Elizabeth Mead and Edith Long a Silver Spoon My Will is That the said Stephen Crowch and John Bennett their Executors or Administrators shall not be Answerable for any Loss that shall happen in placeing the said Ninety Pounds or any part thereof out at Interest All the rest of my Money Goods and Chattles I give devise and bequeath unto my Two Sons Richard Randall and John Randall Whom I Mae Executors of this my Last Will and Testament In Witness whereof I have hereto set my Hand and Seal this Sixth Day of August In the Year of our Lord One Thousand Seven Hundred and Thirty ffive And in the Ninth Year of the Reign of our Sovereign Lord George the Second by the Grace of God of Great Britain ffrance and Ireland King Defender of the ffaith and so forth The Mark of Ann Randall
