In the name of god Amen the eleventh Daye of March a thousand ffyve hundred eightie nyne I William Diet of Veny Sutton in the countie of wiltes yeoman beinge in bodie sicke but thankes be to god in good and perfect remembrance Do make here my laste will and testamente in manner and forme following ffirste I bequeathe my soule to Allmightie god my maker and to Jesus Christ my redemr and my bodie to be buryed in the churche yarde accordinge to the discretion of my executor Item I give unto oure Ladie churche at Sarum ffower pence Item I give an heifer Bullocke to the releife of the poore of the parishe of Sutton according to the discretion of the parishe Item I give my ploughe horse and oxen with all that belonge unto yt to the use of my children and childers children Provided allwaies that my Wife shall have the oxe ploughe to her owne use untill Michaelmas next comminge after the date hereto without the interruption of my children Item I give ffyve younge Beasts to the use of my children and childres children Item I give unto Robert Chaumberlayne tenne chilver sheepe Item I give all my wheate in Godfurlonge to the saied Robert Item I give all the reste of my sheepe to the use of my children and children to be Devided amongst them accordinge to the discretion of Thomas Phill and William Coney Item I give unto Anthonye Diet my sonne twelve quarters of Barley or twelve pounds Item I give the Mowe of Wheate in the Weste ende of the barne unto Henry Hendie Item I give unto Alice Hendy a crocke and a Lymbecke Item I give unto Alice Connie one cowe Item I give unto my Daughter Edithe Eyres one cowe Item I give unto Stephen Mattocke one Bullocke of a Yere olde Item I give the reste of my kyen to the use of my children and childers children to be distributed amongst them accordinge to the discretion of Thomas Phill and Willm Connie Item I give an heyfer unto my Sister Alice Phill of the age of twoe yeres Item all the reste of my goodes moveable and unmoveable not bequeathed and given I give unto Ellinor my Wife whome I make my sole and only executrix of this my laste will and testamente And do revoke and utterlie deney all former willes and Deedes before this tyme made And I ordeyne my Welbeloved in Christe Thomas Phill and William Connie and Thomas Lockyer whome I make my overseers of this my laste Will and Testatmente / Debtes owinge unto William Diet/ Item William Savidge of Bloxforde dothe owe me ffower poundes for a yoke of oxen which he gave his worde for them/William Diet / Item I give unto Thomas Chamberleyn one sheepe Item I give unto Jane Chamberleyn two sheepe Item I give unto Margarett Chamberleyn a sheepe Item I give unto Ousely (?) Bishopp ten shillinges which John Rypp dothe owe me Item I give unto Nicholas Moyner a Lambe/Signed sealed and delivered in the presence of us William Smithe ffranceys Cotton John Chamberleyn Item I give unto Joane Harris a Lambe Item I give unto William Browne a lambe Item I give unto William Cave a lamb Item I give unto Thomas Lokyer one yowe
