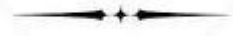




Disposal of War Medals to Australian Soldiers' Next-of-Kin

The following letter was sent by Australian Imperial Force, Base Records Office, Victoria Barracks, Melbourne, to a relative of a deceased Australian Soldier from World War 1 giving an explanation of how the War Medals are distributed.



Dear Madam,

It is noted that you are registered on the records of the late Private _____, ___ Battalion, as next of kin, but in order that the instructions under the "Deceased Soldiers Estates Act 1918" may be properly complied with when disposing of War Medals, &c., I shall be glad to learn whether there are any nearer blood relations than yourself to the above-named, for instance, is his father still alive, if so I shall be much obliged for his name and address at your earliest convenience.

The provisions of a Will have no bearing upon the distribution of Medals unless they are specifically mentioned therein, such mementos being handed over in the following order of relationship, unless good and sufficient reasons for varying the procedure are stated:-

Widow, eldest surviving son, eldest surviving daughter, father, mother, eldest surviving brother, eldest surviving sister, eldest surviving half-brother, eldest surviving half-sister.


