In the Name of God Amen I Ann Fricker of Tisbury in the County of Wilts Widow being at this present time Thank God in a good State of Health mind memory Understanding Do make and Declare this to be my last Will and Testament in the following manner ffirst of all it is my Desire I may be Buried in as ffrugal a manner as can be done with Decency To my two sons Stephen and Henry ffricker I Give the Sume of fifty Pound Each to be paid to them at the End of two whole Years after my Decease And in Case either of my said two sons Stephen and Henry Should happen to Dye before before their said Legacy shall become Due I Give the said ffifty Pounds to be equally Divided Between the Children of my said Son Stephen Fricker To my Daughter Bridgett Small I Give the Sum of Sixty ffive pounds to be paid her at the end of One whole Year after my Decease To her ffour Children William Thomas Robert and Ann Small I Give the Sume of fifty Pound each to be paid them Severally at the Age of Twenty three Years the Interest of which Severall Legacys to be paid to their Mother Bridgett Small until the principal shall become Due as afore said To my Daughter Ann Lawes I Give the Yearly Interest of One Hundred and thirty Pounds during her Life After her Death I will that the said yearly Interest be disposed at the Discretion of my Executor for the Use of her Children untill the Principall Money shall become Payable which I Give them as follows To her Son Thomas fourty pounds To her Daughter Ann Thirty Pounds To her Daughter Elizabeth Thirty Pounds and to her Daughter Sarah Thirty Pounds to be paid them severally at the Age of Twenty three Years To my Grand Children James Elizabeth and Ann Hayward I Give the Yearly Interest of One Hundred pounds to be Disposed of for their Use at the Discretion of my Executors untill the Principall Money shall become payable which I Give them as follows To James Hayward fourty pounds To Elizabeth Hayward Thirty Pounds and To Ann Hayward Thirty Pounds to be paid them Severally at the Age of Twenty three Years If any of my said Grand Children should happen to Dye before the Legacy shall become Due I will that the Share of the Disceased be Divided equally among the remaining Children of the same Family I Give to my Kinswoman Elizabeth Askew the Sum of Twenty Pounds to be paid her at the end of One Year after my Decease To the Poor of the Parish of Alverleston I Give the Sum of five pounds to be disposed of at the Discretion of my Executor All my Clothes and wearing Apparel I Give to my Daughters Bridgett Small and Ann Lawes to be Equally Divided between them all my Household Goods I Give to my Grand Children Robert and Anne Small to be Divided equally between them I Give to my Son Stephen Fricker my Seal Ring To my Son Henry my Stone Ring To my Daughter Bridgett Small my weding Ring To my Daughter Anne Lawes my Mourning Ring my Will is that the Interest of the Severall Legacies above mentioned Shall be paid at the Rate of Four Pounds P Cent P Annum And it is likewise my Will that notwithstanding the time limited when the above mentioned Legacys shall become Due my Executor shall not be Obliged to pay any of them left one whole Year after my Decease All the Rest residue and remainder of My Monies Debts and Personal Estate whatsoever and wheresoever and of what kindsoever I Give and bequeath to my Son Thomas Fricker whome I Constitute and Appoint whole and Sole Executor of this my Last Will and Testament In Witness whereof to this my Last Will and Testament I have Sett my hand and Seal this Tenth day of December in the Year of our Lord One Thousand Seven Hundred and Fifty *Anne Fricker*
