This is the last Will and Testament of me Abraham Henly of Tockenham in the County of Wilts Gentleman which hereby revoking all former Wills by me at any time heretofore made I make publish and declare as follows I will that all my just debts funeral and testamentary expences be paid and discharged by my Executors hereinafter named out of the first Monies which shall come to their hands by virtue of this my Will I give and bequeath to my Nephew John Henly the Sum of ffour hundred pounds To the Daughter of my deceased Niece Mary Canning the Wife of Robert Tanner of Vere Street Cavendish Square London Surgeon the Sum of One hundred pounds To my Niece Hannah Boak the Sum of ffour hundred pounds To my Nephew Thomas Henly of the Parish of Lineham in the said County Gentleman the Sum of One thousand pounds To my Niece Elizabeth Cripps Wife of Charles Cripps of Purton in the said County of Wilts Gentleman the Sum of ffour hundred pounds To my Niece Mary Washbourne Daughter of Broome Pinniger the Sum of Three hundred pounds To my Niece ffrances Henly Rumbell the Sum of ffour hundred pounds To my Nephew Timothy Rumbell ffive hundred pounds To my Niece Ann Warman Widow of Stephen Warman of Purton in the said County of Wilts Gentleman the Sum of one hundred and fifty pounds To Anne Buckland Daughter of my Niece Elizabeth Buckland the Sum of ffour hundred pounds To my Niece Mary King Wife of Henry King of Calne in the said County of Wilts Surgeon the Sum of Eight hundred pounds To my Niece Martha the Wife of Jacob Large the Sum of ffour hundred pounds To my Niece Sarah Little the Wife of William Little of Hamhill in the County of Gloucester ffour hundred pounds To my Nephew John Nicholls ffour hundred pounds To my Niece Ann Ruck Wife of Edmund Ruck of Down Ampney aforesaid the sum of ffive hundred pounds To my Cousin Elizabeth Noyes Wife of John Noyes the Sum of One hundred pounds To my Great Nephew William Bridges the Sum of One hundred pounds To my Great Niece Sister of the said Nephew William Bridges the Sum of One hundred pounds I give the Sum of One thousand and five hundred pounds to be equally divided between all the Children of my Niece Sarah Maskelyne decease except her Daughter Sarah Tanner All which said several Legacies I will be paid the several Legatees by my Executors herein after named within twelve calendar months next after my decease To Lucy Maskelyne the Wife of Jasper Maskelyne of Wootton Bassett in the said County of Wilts I give my Yellow Bed Bedstead and Hangings standing in the Room over the Parlour together with the Bolster Pillows one pair of Sheets and one pair of Blankets To Elizabeth Rumbell Maskelyne my great Niece I give the whole of the ffurniture in the middle Room above Stairs Also I direct my Executors to distribute the Sum or Value of Twenty Pounds among the poor of the Parish of Tockenham aforesaid in such Alms way and manner as they shall think best and as soon after my ffuneral as they shall think proper All the Rest residue and Remainder of my Goods Chattels Monies Securities for Money ffarming Stock and all other my Personal Estate and Effects whatsoever and wheresoever of which I shall die possessed or seized or in any way entitled unto I give devise & bequeath the same to my Nephews Timothy Rumbell and Charles Rumbell their Executors and Administrators and Assigns to and for their own use and benefit And I do hereby make nominate

constitute and appoint the said Timothy Rumbell and the said Charles Rumbell Executors of this my Will In Witness whereof I the said Abraham Henly the Testator have to this my last Will and Testament set my hand and seal this third day of April in the Year of our Lord One thousand eight hundred & thirty \_ Abm Henly
