I Samuel Diplock of Trowbridge Wilts Linen Draper revoking all former Wills by me made do declare this to be my last Will & Testament ffirst I give & bequeath unto John Edwards of Hilperton in the County of Wilts Common Brewer Joseph Stancomb of Trowbridge in the said County Clothier & Richard Wearing of Hilperton in the said County Tallow Chandler their Heirs Exors and Assigns all my real personal & Landed Property of whatsoever kind and wheresoever situated In Trust to be appropriated by him to the sole use of my Son & Heir John Diplock & that my Personal Property be so soon as convenient sold & disposed of to the best advantage and the Monies arising therefrom to be invested in the public ffunds

or Land Security for that express purpose and I direct & appoint my aforesd Trustees to give every requisite Education to my said Son John to qualify him for Business & afterwards to Apprentice him or put him as a Clerk in some Office agreeable to his own wishes & at the discretion of my said Trustees should my son not arrive at the age of twenty one years in such case I give & bequeath to Joseph Dunn of Hilperton in the aforesd County Clothier his Heirs Exors Admors & Assigns one undivided Moiety or half part of my Landed Property situate in the Parish of Trowbridge in the aforesd County & the other undivided moiety or half part of my Landed Property situate as before mentioned I give & bequeath unto John Bell Junr of Trowbridge in the aforesd County Clothier his Heirs Exors Admors & Assigns & likewise in such case that my son not arrive at the age of twenty one years of age that my Personal Property of every kind soever to be equally divided between my Brothers & sisters who may be living at the time of my said son's decease And I further direct that the said John Edwards Joseph Stancomb and Richard Wearing their Heirs Exors Admors & Assigns to pay all my just Debts ffuneral Expences and the Expences of proving this my last Will & Testament out of my aforesaid Personal Property & I hereby appoint the aforesd John Edwards Joseph Stancomb and Richard Wearing my joint Exors of this my Will in Witness Whereof I the said Samuel Diplock have to this my last Will & Testament contained in two Sheets of Paper set my hand & Seal to wit to the first Sheet my hand & to the second & last my hand & seal this twenty second day of October in the year of our Lord in the year of our Lord one thousand eight hundred & ten *Saml Diplock*
