In the Name of God Amen I William Brewer of Trowbridge in the County of Wilts Gentleman being weak in Body but of sound and disposing Mind Memory and Understanding do make and ordain this to be my last Will and Testament in manner and fform following (that is to say) ffirst I give and bequeath unto my Nephew John Morley of the City of London Taylor one of the Sons of Joseph Morley of Trowbridge aforesaid Scribler the Sum of twenty Pounds to be paid to him in twelve Calendar Months after my Decease Also I give and bequeath unto my Nephew James Morley of Trowbridge aforesaid Taylor another Son of the said Joseph Morley the Sum of twenty Pounds to be paid to him in twelve Months after my Decease Also I give and bequeath unto my Nephew Joseph Morley the younger another Son of the said Joseph

Morley the Sum of twenty Pounds to be paid to him on his attaining the Age of twenty one Years Also I give and bequeath Isaac Morley another Son of the said Joseph Morley the elder the Sum of twenty Pounds to be paid to him on his attaining the Age of twenty one Years All the rest residue and remainder of my Goods Chattels Moneys and Personal Estate whatsoever and wheresoever or of what kind or Nature soever (after all my just Debts and ffuneral Expences shall be first thereout paid off and satisfied) I give and bequeath the same and every Part thereof unto my Sister Abigail Brewer her Executors Administrators and Assigns for ever And I do hereby constitute and appoint my said Sister Abigail Brewer sole Executrix of this my Will And Lastly I do hereby revoke and make void all Wills and Testaments by me at any time heretofore made and do declare this to be my last Will and Testament In Witness whereof I have hereunto set my Hand and Seal the sixteenth Day of August in the fifth Year of the Reign of our Sovereign Lord George the third by the Grace of God King of Great Britain and so forth And in the Year of our Lord one thousand seven hundred and sixty five *Willm Brewer*
