This is the last Will and Testament of me Mary Ingram of Upton Lovell in the County of Wilts Widow I give & bequeath unto my three Grand Children George Ingram ffisher Mary Lawrence ffisher & Ann Hawes ffisher the sum of nineteen pounds & nineteen shillings each to buy Rings & Mourning I give & bequeath unto Christopher ffleetwood & George ffleetwood Nephews of my late deceased Husband the sum of fifty pounds each free of all Legacy Duty which is to be paid out of my Estate I give & bequeath unto Susannah the Wife of my Son Christopher Ingram all my Wearing Apparel Trinkets Jewels and Ornaments of my person except the Mourning Ring given to me for my late deceased Daughter Elizabeth ffisher which I give to her Daughter the said Mary Lawrence ffisher I give & bequeath all my Household Goods & ffurniture Plate Linen and China unto & equally between my two Sons John Ingram & Christopher Ingram and give and bequeath unto my two Maid Servants Martha Cooper & Mary Draper the sum of two Guineas each All the Rest and residue of my Goods monies & Securities for money Estate and Effects whatsoever and of what nature or kind soever I give and bequeath the same unto my Son Christopher Ingram to and for his own absolute use and benefit I make & appoint my said Son Christopher Ingram sole Executor of this my Will In Witness whereof I have hereunto set my hand &
