This is the last Will and Testament of me Edward Bennett of Smallbrook in the Parish of Warminster in the County of Wilts Gentleman first I will that all my just debts funeral and testamentary expences be fully paid and satisfied I give and bequeath unto William Batt of Warminster aforesaid the sum of nineteen pounds of lawful money of Great Britain to Eve Batt his Wife the like sum of nineteen pounds to and for her own proper use and benefit independent of her present or any future husband who shall have nothing to do therewith nor shall the same or any part thereof be in any manner subject or liable to his debts management or controul but the receipt of the said Eve Batt notwithstanding her present or any future coverture shall be a good and sufficient and effectual discharge to my Executors hereinafter named for the payment of the same which two several legacies I will and direct shall be paid to them within three calendar months next after my

decease I give and bequeath unto Eliza Jane Batt daughter of the said William and Eve Batt the sum of nineteen pounds of lawful money aforesaid to Eliza Ann Batt another daughter of the said William and Eve Batt the like sum of nineteen pounds of like money aforesaid and to Thomas Batt the Son of the said William and Eve Batt the sum of ten pounds of like money aforesaid which said last three mentioned legacies I will and direct shall be paid to the said several Legatees on their respectively attaining the age of twenty one years I give and bequeath unto Ann Bennett Seagram Wife of ffrederick ffrowd Seagram of Warminster aforesaid Surgeon the sum of nineteen pounds of like money to purchase a mourning ring to be paid immediately on my death I give and bequeath unto my Sister Jane Bennett all and singular my household goods and furniture of every description for and during the term of her natural life and immediately on her death as to all and singular the same household goods and furniture I give and bequeath the same and every part thereof unto the said William Batt his executors administrators and assigns absolutely and as to all the rest residue and remainder of my monies and securities for money goods Chattells and effects and all other my estate both real and personal to which I am in any way entitled unto after payment of the aforesaid legacies I give devise and bequeath the same and every part thereof unto my said Sister Jane Bennett to and for her own sole absolute use and benefit and I make nominate constitute and appoint her my said Sister Jane Bennett and the before named ffrederick ffowde Seagram Joint Executrix and Executor of this my last Will and Testament hereby revoking and making void all former Wills by me at any time heretofore made In Witness whereof I have hereunto set my hand and seal this twenty fifth day of May in the year of our Lord One thousand eight hundred and twenty two *Edward Bennett*
