Will of Isaac Nowell



Proved 1832

This is the last Will and Testament of me Isaac Nowell of Warminster Wilts ffreestone Mason I give I give and devise unto my Trustees and Executors hereinafter named and their heirs All my ffreehold Messuages Lands Tenements & Hereditaments whatsoever To hold to them their heirs and assigns In trust that they do and shall absolutely sell and convey the same to any person or persons willing to become purchaser or purchasers thereof at such time or times as they my said Trustees shall think most proper and advantageous & for the best price & prices that can and may be gotten for the same And I direct that on such sale or sales the receipt or receipts in writing of my said Trustees and Executors for the purchase money shall be a good and sufficient discharge to the purchaser or purchasers of the same Hereditaments or any part thereof & that such purchaser or purchasers shall not answerable for the application of the same And that the rents and profits of the same Hereditaments until the sale thereof shall be received held and enjoyed by the person or persons for the time being entitled to the income of my residuary estate I give and bequeath unto my said Trustees and Executors all my Stock in Trade of every sort and description household Goods furniture monies securities for money debts personal Estate and Effects whatsoever and wheresoever Upon trust that they do and shall either dispose of my stock in trade or carry on my business as they shall consider most advantageous and call in collect and receive all debts sum and sums of money due and owing to me from any person or persons whom soever And I direct that if my said Trustees shall think fit to dispose of my said business they shall have power to accept of any personal security from the person or persons willing to purchase the same for payment of the purchase money and that they shall not afterwards be answerable for the insufficiency of such Security or for any loss which may happen from their taking such personal security But my wish and desire is that my trustees shall if they think it most adviseable but I leave it to their discretion to carry on my business in my name by the employment of one Mr Thomas Waples or some fit person or persons at a salary until my eldest Son shall attain his age of twenty one years when he may be able to take to such business in conjunction with some competent person And I appoint my Brothers Benjamin Nowell and Philip Nowell Executors and Trustees of this my Will and I direct them that until the disposal of my business they do pay and apply such part of my Estate as they may think proper to and for the maintenance support and benefit of my Wife and all my Children And I direct my Trustees to pay to each of my three eldest Children on their respectively attaining the age of twenty one years the Sum of Twenty Pounds And as to all the residue of my monies estate and effects of which the produce of my ffreehold Estate on sale is to form a part Upon trust to place the same out at interest and pay the interest thereof to my Wife during her life if she shall so long continue my Widow and unmarried again And after her death or marriage again then Upon trust to apply the income thereof for the maintenance and bringing up of my two youngest Children until they shall attain the age of twenty one years when they are respectively to be paid the Sum of Twenty Pounds each and when my youngest Child shall have attained the age of twenty one years then after the decease or marriage again of my said Wife Upon trust and I desire my Trustees and the survivor of them to pay and equally divide all the residue of my Estate unto and between all and every my Children who shall attain the age of twenty one years share and share alike to be a vested interest in them respectively on attaining such age though not to be payable until after the decease or marriage again of my said Wife As witness my hand and seal this twenty seventh day of September one thousand eight hundred and thirty one I Nowell
