give devise and bequeath to William Wansey of the City of Bristol Merchant his Heirs and Assigns All that my ffreehold Estate in the Island of Nevis in America formerly in the Possession of Richard Merreweather and Since of my Brother William Slade To hold to him his Heirs and Assigns for ever But subject to the Payment of the Sum of Seventy Pounds thereout in manner following (that is to say) Ten Pounds thereof to Mary Carpenter Wife of Thomas Carpenter of Warminster aforesaid Yeoman at the end of Three Months next after my decease and the other Sixty Pounds to James Carpenter Son of the said Thomas at his Age of Twenty one Years And my Will is the Interest of the said Sixty Pounds shall be paid by half Yearly Payments to the said Thomas Carpenter for and towards the Maintenance of his said Son until his Age of Twenty one Years But if the said James shall happen to dye before he shall arrive to the Age of Twenty one Years Then I Will that the said Sixty Pounds shall go and be paid to John Mary and Ann his Brother and Sisters and the Survivors and Survivor of them share and share alike Also all the rest residue and remainder of my Moneys Goods Chattels and Effects and all other my Real and Personal Estate whatsoever I give and bequeath to the said Mary Carpenter and do make her sole and only Executrix of this my last Will and Testament In Witness whereof I have hereunto set my Hand and Seal the Twenty seventh day of January in the Year of our Lord 1747 The Mark of John Slade
