The Holt farm is situate in Holt within a few minutes' walk of the church and about half a mile from the Holt station on the Great Western Railway. It comprises a roomy dwelling or farmhouse, built in the Elizabethan style and sundry farm buildings attached, and, with some outlay could be made a desirable family residence. The lands adjacent thereto comprised in the first four lots are pasturage of first class fertility and well supplied with water.
